Your Privacy is important to us and in Compliance with the GDPR regulations NEST will keep all personal information safe and secure. We have put in place suitable physical, electronic and managerial procedures to ensure this.

What personal data do we collect and how do we use it?

Website:

Our website does not contain cookies therefore no personal data is collected from visiting our website. It may contain email addresses to websites that may be of interest. We do not have any control over any of these websites. Therefore, we cannot be responsible for the protection and privacy of any information which you provide whilst visiting such sites and such sites are not governed by this privacy statement. Course organisers:

NEST do not have their own venue, and as such do not take bookings from individual learners. All courses are run at the venue provided by the course organiser. Any personal information we collect is provided during the organisation, delivery, and payment of the course, and is used only for this purpose.

Sub-contractors:

The information we hold is provided by the sub-contractor for the purpose of payment of invoices and for the offer of work when it becomes available. It will not be used for any other purpose without prior consent.

Learners' Privacy:

We do not have our own venue and therefore do not take bookings from individual learners.

For the purpose of GDPR, all our regulated courses are registered and certified through the relevant awarding organisation (Qualsafe Awards, NUCO training or the RLSS (Royal Lifesaving Society)). Personal data is collected during the course administration and assessment process and is on official course paperwork provided by these Companies.
